STATE CONCESSION CARD

The State Concession Card is provided to specific Veterans Affairs pensioners, who are not eligible for the Commonwealth Pensioner Concession card, so that those individuals can receive a 50% rebate on Local Government Rates and Water Authority of WA water, sewerage and drainage rates.

The following categories of eligible pensioner are issued the State Concession Card without means test:

- Totally and Permanently Incapacitated Pensioners (TPI)
- Special Rate Disability Pension (SRDP)
- Extreme Disablement Allowance (EDA)
- Blinded War Pensioners
- Tuberculosis sufferers (as determined by Veterans Affairs)

The following categories of eligible pensioner are issued the State Concession Card after satisfying a means test:

- War widows and war widowers
- Widowed mothers of deceased unmarried members of the defence forces
- Unmarried mothers of deceased unmarried members of the defence forces

The means test restricts the State Concession Card to individuals who would otherwise satisfy the income test for the Pensioner Concession Card.

There are a number of Veterans Affairs categories which are not eligible for the SCC, including Totally and Temporarily Incapacitated (TTI). The categories above are the only ones currently identified as eligible for the SCC.

The card entitles the holder to discounts on Local Government rates and Water Authority of WA water, sewerage and drainage rates, it is relevant to landowners only. Therefore, the card is issued to eligible persons owning or having a relevant interest in the residential property which they occupy. The concession must be applied to the owner-occupied dwelling only.
